This includes a 24-hour resource line, case management, extensive legal advocacy, trauma-focused therapy, and specialized services for families. All on-going services are offered in both English and Spanish. All advocacy services are provided free of charge. Services are developed using empirically supported principles so as to be most effective.

The criteria was to assist with an outcome that would enhance survivors chance of progressing in therapy. The outcomes included 1) Access to Services 2) Increased Housing Stability 3) Increased Economic Stability 4) Increased Safety or 5) Meeting Basic Needs. The Clients had to fill out a form that stated how the client would benefit from this assistance. The funds could not go to the client, but had to go to the vendor who had the service or good required by the client. This form had to be approved by the director of programs and an invoice from the vendor had to be provided. If the service or goods was approved we paid the vendor directly.

KCSARC's compensation philosophy values both internal and external equity. All positions are internally evaluated and assigned a grade based on a standardized set of criteria, including required knowledge and skills, scope of responsibility and decision-making, interpersonal and leadership demands, level of work autonomy, and degree of innovation or problem-solving required. Regular benchmarking of compensation for all positions against relevant external market data occurs to ensure our pay practices remain competitive and equitable. The compensation grid is based on an industry standard with 10 job grades and 10% between each grade. We believe that we have a competitive compensation system which honors the value of the position in the general market as well as promoting equity within the agency. The KCSARC Board of Trustees has used an independent review in coordination with an HR Consultant to set the Chief Executive Officer's compensation. This was last reviewed in 2024. The Board of Trustees reviews key employees' compensation; however, final decisions regarding compensation are in the purview of the Chief Executive Officer.
